01.01.1998	Official launch of Sardinian operation after obtaining a regional operator licence
22.04.1998	Awarded a licence for the provision of voice telephony services in Sardinia, Milan and Rome
28.08.1998	Signing of an interconnection agreement with Telecom Italia
22.10.1998	NETCARD, first internet pre-paid subscription
01.11.1998	Distribution of its services in the Milan and Rome areas, launching the first pre-paid phone service for residential users (Tiscali 10030 and RICARICASA)
26.11.1998	Venture capital agreement with Kiwi I Ventura-Serviços SA, which takes a 10% stake in the company via a capital increase
17.12.1998	Signs a reverse interconnection agreement with Telecom Italia
10.03.1999	Awarded a licence for the supply of voice telephony services throughout the country
31.03.1999	Launch of TiscaliNet, first free Internet connection service
14.07.1999	Completed the installation of 24 plants, announces the widening of TiscaliNet services nationwide in Italy and the acquisition of a owned e-commerce platform
27.10.1999	IPO: Tiscali lists on the Nuovo Mercato

- 23.12.1999** Launch of European expansion plans with important acquisitions in France, Switzerland, Czech Republic, Belgium, Germany
- 07.09.2000** Acquisition of World Online: wide European expansion in 15 countries plus South Africa with one of the main integration deals of the industry at European level, becoming a pan-european leader in Internet services
- 08.01.2001** Announce of a bid for Liberty Surf, the second ISP in France
- 25.11.2001** Announce of the first important agreement for legal digital music sale in Europe through a deal signed with OD2, company founded by Peter Gabriel.
Since then Tiscali acts in the frontline with many activities for promoting the legal commerce of digital music
- 08.07.2002** Public auditing with the European Commission: it is the beginning of an active campaign for the liberalization of European broadband market.
- 19.09.2003** Opening of the new headquarters at Sa Illetta (Cagliari), in which all group's activities will be concentrated
- 16.08.2004** Refocusing on markets with the highest value creation and disposal of activities in "non core" markets.
- 12.08.2006** Acquisition of Video Networks Ltd and its IPTV service platform. The agreement, beyond significantly strengthening its position as Tlc operator in the UK, represents a strategic step for the development of Triple Play offers at international level.
- 01.03.2007** Tiscali TV launch in UK
- 13.07.2007** Acquisition of Pipex broadband and voice division, consistent with the refocusing project and the growth in high value creation countries.
- 27.07.2007** Agreement with Telecom Italia for the offering of mobile virtual operator in Italy
- 11.12.2007** Tiscali TV launch in Italy
